EXPLANATORY MEMORANDUM

This Explanatory Memorandum has been prepared to assist shareholders with their consideration of the Resolutions to be put to the Annual General Meeting to be held Tuesday 19 November 2013.

ORDINARY BUSINESS:

Financial Statements and Reports

The *Corporations Act 2011* requires that the report of the Directors, the Auditor's Report and the Financial Statements be laid before the Annual General Meeting. In addition, the Company's Constitution provides for such Reports and Statements to be received and considered at the Meeting. Apart from the matters involving remuneration which are required to be voted upon, neither the *Corporations Act 2001* nor the Company's Constitution require a vote of shareholders at the Annual General Meeting on such reports or statements; however shareholders will be given ample opportunity to raise questions with respect to these Reports and Statements at the Meeting.

Following consideration of the Reports, the Chairman will give shareholders a reasonable opportunity to ask questions about or comment on the management and audit of the Company.

There is no vote on this item.

Resolution 1 - Directors' Remuneration Report

Shareholders are asked to adopt the Remuneration Report. The Remuneration Report is set out on pages 4 to 7 of the 2013 Financial Statements. The *Corporations Act 2011* provides that at a listed company's Annual General Meeting, a resolution that the Remuneration Report will be provided at the Meeting.

The vote on the Remuneration Report is advisory only, and does not bind Directors.

Voting Exclusion Statement:

In accordance with section 250R(4) of the *Corporations Act*, the Company will disregard votes cast on by a member of the Company's Key Management Personnel whose remuneration details are included in the Remuneration Report, or a Closely Related Party of such a member, unless:

- (a) it is cast by a person as a proxy for a shareholder who is entitled to vote, in accordance with a direction on the proxy form; or
- (b) it is cast by a person chairing the Meeting as proxy for a shareholder who is entitled to vote, and the person chairing the Meeting has received express authority to vote undirected proxies as the Chairman sees fit.

Retirement of Directors

Both of the directors who retire by rotation at the 2013 Annual General Meeting, Mr John Pressler and Mrs Frances McLeod, have informed the Board that they will not seek re-election. The company therefore has no directors standing for re-election this year.

After serving as a Director of Wide Bay Australia Ltd for 25 years, including 12 years as Chairman, Mr Pressler has decided to retire from the Board. The Board wishes to express its gratitude to Mr Pressler for his valuable contribution to Wide Bay Australia over many years and wishes him all the very best for the future.

Mrs Frances M McLeod MAICD, FIFS

Mrs McLeod has decided not to seek re-election as a Director of Wide Bay Australia Ltd after serving as a Director for 10 years. The Board wishes to thank Mrs McLeod for her substantial contribution and wishes her all the very best for the future.

Appointment of Proxy

Voting 100% of your holding: Direct your proxy how to vote by marking one of the boxes opposite each item of business. If you do not mark a box your proxy may vote as they choose. If you mark more than one box on an item your vote will be invalid on that item.

Voting a portion of your holding: Indicate a portion of your voting rights by inserting the percentage or number of securities you wish to vote in the For, Against or Abstain box or boxes. The sum of the votes cast must not exceed your voting entitlement or 100%.

Appointing a second proxy: You are entitled to appoint up to two proxies to attend the meeting and vote on a poll. If you appoint two proxies you must specify the percentage of votes or number of securities for each proxy, otherwise each proxy may exercise half of the votes. When appointing a second proxy write both names and the percentage of votes or number of securities for each in Step 1
