However, if the closing balance shown on your credit card statement is less than \$30, your minimum repayment is the closing balance.

Interest-free period	Up to 55 days for purchases
Interest on cash advances	9.74% p.a.
Balance transfer rate	0% p.a. for the first 12 months

Late payment fee	\$20 if you do not pay the minimum repayment by the payment due date shown on your credit card statement
